Fleet insurance conditions. Exclusion and Limitation: Self-drive Hire.

1. Prior to the commencement of any hire, the insured (Preston CT) will have:
  - a. Verified the address of the hirer (you).
  - b. Inspected the driving licence of the hirer and any other permitted driver.
  - c. Satisfied themselves that the hirer/driver is not amongst the excluded persons enumerated below.
2. That the insured vehicle will **not** be let out on hire to or driven by any person;
  - a. Under the age of **twenty-one (21)**.
  - b. Over the age of **seventy (79)**.
  - c. Who has held a licence for less than **two (2) years**.
  - d. Who has had their driving licence suspended **at any time**.
  - e. Who has been convicted of **any** offence in connection with the driving of a motor vehicle or motorcycle and/or has had their driving licence endorsed or penalty points imposed during the five (5) years immediately prior to any hiring or has a prosecution outstanding for any such offence. Parking and not more than two speeding offences in the past five (5) years may be ignored.
  - f. Who has any physical impairment, infirmity, suffers from fits, diabetes or heart condition.
  - g. Who has had their motor insurance declined or renewal refused or policy cancelled or special terms imposed as a result of claims experience by any motor insurance.
  - h. Who is a **student** or **undergraduate** under the age of **thirty (30)** years.
  - i. Who is engaged wholly or partly in the profession of or is a professional sportsperson.
  - j. Who is a jockey or connected with racing of any sort.
  - k. Who is a member of any foreign armed forces?
  - l. Who while driving has been involved in more than **one accident** during the three years immediately prior to any hiring.
3. The insured vehicle will only be let out on hire to a person who has signed and completed a hirer/driver proposal immediately prior to any hiring.
- The insured vehicle may be used for social, domestic and pleasure purposes or the business of the hirer (other than being let out for hire).

**Clear Air Zone charges must be paid when entering any of the following cities: Bath, Birmingham, Bradford, Bristol, Greater Manchester (under review), Portsmouth, Sheffield, and Tyneside – Newcastle and Gateshead, London and various cities in Scotland.**  
**(failure to pay the charges will make the hirer liable for all penalty charges).**

**USE.**

1. **Purpose of use.**
  - a. This insurance does not operate and the **insurer** will not be liable if the insured vehicle is being used for purposes other than as shown on the policy and certificate of insurance.

**Exclude Drivers under age.**

1. **Exclusion and limitation: Driving by persons as detailed in the schedule.**
  - a. This policy excludes and the **insurer** will not be liable while the insured vehicle is being driven by or for the purpose of being driven is in the charge of any person under the age of twenty-one (21).
